IPHA is working with 18 organizations across the state of Illinois to provide technical assistance to small

The Litchfield Chamber of Commerce and its co-sponsors are also providing local agencies and institutions the opportunity to set up exhibit booths to provide information about their services and how they benefit small businesses.

 - \$5,000-\$150,000 grants totaling \$250M made available by ARPA funds (up to \$250,000 for hotels)

Frequently Asked Questions

How much is being made available, and when does DCEO anticipate exhausting the funds?

• \$250 million will be made available for grants of \$5,000 to \$150,000 (Grants for hotels may be as high as \$250,000).

• Applications will be open from now to October 13.

• DCEO anticipates making awards on a rolling basis, based on priority criteria, and exhausting all funds by shortly after the application period.
